- 1 By April 1 Father must give Mother written notice of the desired times for extended Summer vacation. Possession can be for 30 days, broken into two periods of at least seven consecutive days. If such notice is not given, summer possession will be from 6:00 p.m. on July 1 until 6:00 p.m. on July 31.
- 2 By April 15 Mother can give Father written notice and have possession one weekend during Father's Summer possession.
- 3 By April 15 Mother can give Father written notice and have priority possession for one weekend during the summer. This weekend period cannot interfere with Father's right to possession on Father's day and it cannot interfere with Father's extended summer possession periods.
